In addition, water for sterilisers must be below 15  $\mu$ S/cm. Using water produced by RO ensures that your practice complies with these requirements.

BIOPURE 15 can deliver RO water via its integral dispensing gun or directly to the washer disinfector. It is easy to use and maintain and is designed to fit in a conventional dental cabinet – or can be wall mounted or installed in a standard base unit. The cost of water production is comparable to bottled purified water and eliminates the need for manual handling, plastic disposal and storage.
