

### Research Data Policy Type 3

Submission of a manuscript to the Journal implies that materials described in the manuscript, including all relevant raw data, will be freely available to any researcher wishing to use them for non-commercial purposes, without breaching participant confidentiality.

The journal strongly encourages that all datasets on which the conclusions of the paper rely be available to reviewers and readers. We encourage authors to ensure that their datasets are either deposited in publicly available repositories or presented in the main manuscript or additional supporting files. Please see Springer Nature's [information on recommended repositories](#) and Research Data Policy [Frequently Asked Questions](#).

General repositories - for all types of research data - such as [figshare](#) and [Dryad](#) may be used where appropriate.

The journal also requires that authors cite any publicly available data on which the conclusions of the paper rely in the manuscript. Data citations should include a persistent identifier (such as a DOI) and should ideally be included in the reference list. Citations of datasets, when they appear in the reference list, should include the minimum information recommended by [DataCite](#) and follow *<imprint>* style. Dataset identifiers including DOIs should be expressed as full URLs. For example:

2. The datasets generated during and/or analysed during the current study are not publicly available due [REASON WHY DATA ARE NOT PUBLIC] but are available from the corresponding author on reasonable request.
3. The datasets generated and/or analysed during the current study are available from the corresponding author on reasonable request.
4. Data sharing not applicable to this article as no datasets were generated or analysed during the current study.
5. All data generated or analysed during this study are included in this published article [and its supplementary information files].
6. The data that supports the findings of this study are available from [third party name] but restrictions apply to the availability of these data, which were used under license for the current study, and so are not publically available. Data are however available from the authors upon reasonable request and with permission of [third party name].

Peer reviewers are entitled to request access to underlying data (and code) when needed for them to perform their evaluation of a manuscript.
